**Time-based fees are calculated using the health care standard of a therapeutic hour of 55 minutes.*

Missed Appointment Fee - if cancelled with less than 2 business days' notice, patient is responsible for full price of appointment. Any appointment changes (cancellations, time needed, etc) need to be made 2 business days in advance.

Your office visit fee may include additional time spent on your care outside of the appointment, such as reviewing lab results, analyzing medical history, and coordinating care. For new patients with extensive or complex medical histories, extra time may be required for thorough review. Depending on the scope of work involved, this additional time will either be included in your office visit fee or billed as a separate charge.

We do not accept returns on any products once they are purchased. No exceptions.

See our return policy on the consent form for more detail. There is a 20% restocking fee if you need to return a lab kit. There is a \$50 fee if the kit has expired and you need to order a second one.
